As a condition of allowing Participant to participate either Event, CORI requires that the Participant (by the Participant's Parent/Guardian if the Participant is under 18 years of age) agree to the terms of this **CONSENT FORM FOR PHOTOGRAPHY AND VIDEO RELEASE AND FOR RELEASE FROM LIABILITY**.

1. The Participant (by the Participant's Parent/Guardian if the Participant is under 18 years of age) hereby grants to CORI and its sponsors, the absolute right and permission at any time hereafter to use the Participant's name and likeness (photograph, web, or video image), either alone or accompanied by other material, for promotional purposes in connection with CORI as long as such use is not embarrassing and/or demeaning to the Participant. The Participant (by the Participant's Parent/Guardian if the Participant is under 18 years of age) waives all rights to inspect and approve the finished product, including written copy that may be created in connection herewith to the extent the finished copy, including written copy, is limited to promotional purposes in connection with CORI. The Participant (by the Participant's Parent/Guardian if the Participant is under 18 years of age) waives any claim to further compensation or consideration for the foregoing.

2. Participant (and the Parent/Guardian of the Participant if the Participant is under 18 years of age) understands that participation in the Event will expose Participant to risks of injury including, without limitation, injury from: building, lifting, and using electrical/mechanical robots and robot components; using tools; other participants; dancing and other associated activities. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that neither CORI nor the PAST Foundation selects, employs, supervises or otherwise exercises authority or control over the coaches, mentors, and other participants in the Event. Participant, if 18 years of age or older, acknowledges and agrees that he/she is primarily responsible for his/her safety. The Parent/Guardian of the Participant if the Participant is under 18 years of age acknowledges and agrees that the Parent/Guardian is primarily responsible for the Participant's safety and that the Parent/Guardian will monitor, as appropriate considering the age of the Participant and other factors, the Participant's participation in the Event.

In consideration for CORI's allowing the Participant to participate in the Event, Participant (and the Parent/Guardian of the Participant if the participant is under 18 years of age for and on behalf of the Participant and the Parent/Guardian) assumes all risk of such participation and hereby releases CORI and the PAST Foundation and (except as expressly provided below) all of CORI's and the PAST Foundation's directors, officers, employees, volunteers, and agents from any and all claims for any injury of any kind to the Participant (and the Parent/Guardian) or other damages that may occur as a result of the Participant's participation in the Event, including without limitation any injuries or other damages that may be caused the negligence of CORI and/or the PAST Foundation or negligence of any of CORI's and/or the PAST Foundation's directors, officers, employees, volunteers, or agents (including without limitation negligently failing to adequately investigate or screen coaches, mentors, volunteers, etc.), and agrees not to file any lawsuit or otherwise make any claim against CORI and/or the PAST Foundation and/or any of CORI's and the PAST Foundation's directors, officers, employees, volunteers, or agents for any such injury or other damages. The Participant (and the Parent/Guardian of the Participant if the Participant is under 18 years of age) does not hereby release any claims against any person intentionally causing injury to the Participant.

4. Participant (and the Parent/Guardian of the Participant if the participant is under 18 years of age) understands that photographs, videotapes, and other recordings will be made of participants in the Programs, including the Participant. Participant (and the Parent/Guardian of the Participant if the Participant is under 18 years of age) consents to those photographs, videotapes, and other recordings and the use thereof (i) as part of a record of this Event and (ii) to promote CORI, this Event, subsequent CORI-related events and subsequent CORI-related programs.

Participant (and the Parent/Guardian of the Participant if the Participant is under 18 years of age) has read this document and understands that this Consent and Release Agreement includes a waiver of the right to make injury claims. This document is legally binding.
